US District Judge Alison Nathan,

I recommend the US District Court in Manhattan accept Ghislaine Maxwell's bail application offering of \$28.5 million... with the following stipulations:

<24 Full-time Security Guards on premises\*\*\* [i.e. 12 guards rotating shifts every 8 hours] RV Camper residences on premises.

<Each Security Guard is paid directly by Ghislaine Maxwell Escrow \$20,000 monthly salary per Security Guard

NOTE: Escrow prepaid 6-months in full [i.e. \$480,000/month (x) pre-paid every 6-months = \$2,880,000]

NOTE: Escrow pre-paid prior to release on bail.

NOTE: After six months, if additional 6-month Escrow is failed to be pre-paid, bail immediately revoked.

NOTE: If Court determines 36 Security Guards, Escrow amount increases -as does number of RV campers on premises by six.

<First 3-months, Hourly Skype Chat w/Court Employee of Judge's decision within 10 minutes prior to or, following-top-of the-hour

NOTE: Offer a pre-agreed 7-hour sleep exclusion Hourly Skype Chat timeframe

<Ankle Monitor 24/7/365 or, duration of Bail Term until completion of Case

NOTE: This effort helps ensure Ghislaine Maxwell's safety based upon possible Lolita Island ties to high-ranking Officials... anyone connected with Jeffrey Epstein.

NOTE: Also saves tax dollars in comparison to jail confinement costs [i.e. 10% Forfeiture of Bail Amount upon Court Case Ruling]

NOTE: Based upon old-school **"Innocent until Proven Guilty in a Court of Law."**
