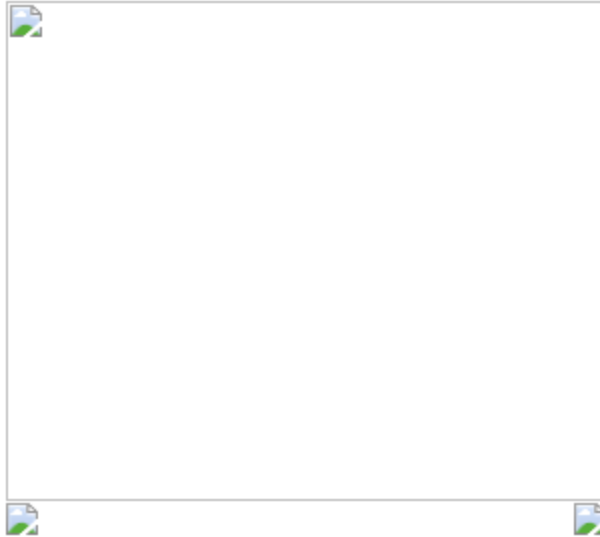
Mr. Epstein, the financier facing sex-trafficking charges, had requested to await trial under home detention at his Upper East Side mansion.
