[REDACTED] advised she is a victim of Jeffrey Epstein who sex trafficked her between 1989 and 1996 in Manhattan, NY alongside [REDACTED] advised that [REDACTED] is the one who trafficked her out of Sweden and scared her out of her marriage and to this day it has ruined her life in Sweden. [REDACTED] advised Epstein's crew has black mailed her and her father [REDACTED] before he died in 2011 and has prevented her from getting healthcare by bribing Swedish authorities. [REDACTED] advised that [REDACTED] came to her apartment in 1990 holding a stun gun and advised her she was also a victim of Epstein.
