Wanted to quickly follow up on our conversation from a couple weeks ago – obviously it was before the world imploded, so understand if you haven't gotten a chance to connect on this yet, but we were wondering about the Lion King question? Just to briefly remind, the Lion King musical first came out in 1997, which we think would have been well after [REDACTED] first trip to New York (based on her recollection as well as the flight records), while the movie came out in 1994 and was in theaters through approximately spring 1995.
